Dear Parent/Guardian

Re: Year 10 - Marwell Zoo, Winchester - Tuesday 23 April 2024

The Science department would like to offer your child the opportunity to visit Marwell Zoo, Winchester. The trip includes entry to the zoo and a workshop called the World Wide Webs, focussing on the themes of food webs and interdependence. The aim of the trip is to provide students with the opportunity to explore the relationships between living organisms through a variety of interactive activities and an opportunity to explore the zoo. If your child is on the animal care course they will be offered the opportunity to attend a workshop looking at how Marwell Zoo fulfils its aim to create a positive lifetime experience for all animals through their evidence-based enclosure design and animal husbandry. This will be an alternative to the World Wide Webs workshop.

The trip will take place on Tuesday 23 April 2024. Students will go to tutor first and then meet at 9am in front of the swimming pool by the coach. Students will travel by coach and will leave school at 9.15am and return at approximately 3.00pm (we will be aiming to leave Marwell Zoo at 2:15pm).

All students will require a packed lunch and a water bottle. If your child is entitled to a free school lunch, this will be provided for them.

Students will be representing the school on this trip so the highest standards of behaviour will be expected. Students are required to wear school uniform.

The cost of a place on the trip is £31.75 which covers entry to Marwell Zoo, the workshop and coach hire costs.

Please complete the parental agreement form online through your ParentPay account to give consent for your child to attend this trip. You will be asked to provide your emergency contact details and any relevant medical information. If a deposit, or full payment, is required this will also need to be paid at the time.

If you have not already activated your ParentPay account and require your login details please do not hesitate to contact the Finance Office at finance@wildern.org.

If you have been notified that we as a school receive Pupil Premium funding for your child, the cost of this trip will be covered. If this is the case, your ParentPay account will automatically

reflect this but please complete the consent, emergency contact information and medical details through ParentPay as usual. The same procedures regarding oversubscription for the trip will apply.

If you would like your child to attend please complete the online ParentPay medical and consent section accompanied by a payment of £31.75 by Friday 15 March 2024.

There are 40 places available. In the event of oversubscription we will endeavour to take into consideration any students who may have missed out on trips previously due to oversubscription, and will allocate any further places by drawing names out of a hat. In the event of a place not being allocated, any monies received will be returned.

When taking a trip we take as many students as possible within the constraints we are bound by. We have to consider venue restrictions, travel arrangements and the impact on the rest of the school when staff are taken out of their curriculum areas to support a trip. Staff running and supporting our school trips often do this outside of their working hours and do so voluntarily. As a school we work extremely hard to get this balance right for all parties involved.
